'Pawsitive Petcare' is our in-home care service which offers pet sitting and nail trims. Pawsitive Petcare also provides consults in raw feeding transitions and general digestion troubleshooting. Pawsitive Petcare does not assume a veterinarians' position and always suggests confirming with your veterinarian to see what is right for your pet.

Rules and regulations

All Pawsitive Petcare (the Doggos) pet parents must attend a preliminary consult prior to the pet care service given.

All parents will provide Pawsitive Petcare (the Doggos) with a copy of house key necessary to gain access to pet. Key will be returned within three days of completion of care service.

All parents understand that any health and safety risks including pet illnesses and wounds must be disclosed to Pawsitive Petcare (the Doggos) during preliminary consult.

In the event of illness or injury during Pawsitive Petcare (the Doggos) service emergency numbers and veterinary clinics disclosed on this contract will be used immediately. Pawsitive Petcare (the Doggos) is not liable for illness or injury during timeline of petcare however

maintains a responsibility to update pet parent on any changes to health and use emergency contact information to access proper health care for pet immediately when necessary.

Pawsitive Petcare (the Doggos) may refuse a service if the pet is aggressive or anxious. Service fees will still apply after one half hour of time spent before ending service.

Pet parents will provide food and inform of any allergies prior to any services that require feeding.

If the Doggos does not uphold their service duties a full refund will be issued to the customer.

Pricing

Services obtained outside of 10km radius to store + \$6 per visit

Syringe based medicine + \$ 5 per visit

In-Home Pet Sitting: \$18 + HST per visit. \$22 + HST premium (holidays)

In-Home Nail Trims: \$20 + HST

Raw Feeding or General Digestion Consult: \$18 + HST per 30 min

Agreement

1. I understand that I am solely responsible for any harm caused by my pet(s) while in the care of 'Pawsitive Petcare (the Doggos)' and release 'Pawsitive Petcare (The Doggo's)' from any liability.
2. I further understand that there are risks of illness or injury in my absence and understand that staff and volunteers will not be held liable for any problems that may occur.
3. I further understand that the staff at 'Pawsitive Petcare (The Doggo's)' have relied on my representation that my pet(s) is/are in good health and non-aggressive towards pets and/or humans.
4. I agree to be available within three days of pet care service completion to pick up my keys unless discussed with management prior to start of service. I understand that all requests otherwise must be made known during preliminary care consult.
5. All fees will be paid prior to pet care service start date upon confirmation of service. If for any reason services are cancelled within two weeks of pet care service start date, all fees will be immediately refunded in the same tender in which they were received. Confirmed pet care services cancelled within one week or less prior to service start will pay a termination fee of one half. Half of fees will be immediately refunded in the same tender in which they were received.

In the event of an emergency, 'Pawsitive Petcare (The Doggo's)' will first attempt to contact the owner, followed by attempt to contact the emergency contact listed by owner. 'Pawsitive Petcare (The Doggo's)' may also directly contact the veterinarian listed or any emergency veterinarian of the staffs' choice if the circumstances are deemed such that immediate treatment is necessary. 'Pawsitive Petcare (The Doggo's)' staff retains sole discretion in emergency matters, without liability, and the owner of the pet(s) agrees to promptly to pay for all medical treatments received.

If you have not contacted us within 24 hours of the return date listed on this contract 'Pawsitive Petcare' (The Doggos) is legally obligated to make sure that the pet in question receives continued care. The pet in question will be taken to the Doggos premises at 4140 Dundas Street West and held for up to one week at which point you will be charged for boarding plus late fee (20\$ a day).
